

# CATALINA EXPRESS BAGGAGE GUIDELINES

PLEASE REVIEW AND PROVIDE A COPY OF THESE GUIDELINES

## **BAGGAGE**

Each passenger is allowed two pieces of personal baggage to be stored in the vessel's luggage hold. **Each piece must weigh under 50 pounds and not exceed 23"x 23"x 37" in size. Any luggage exceeding 50lbs will not be allowed on board. NO EXCEPTIONS!** Trash cans will not be allowed as a baggage carrier. A box within the designated dimensions and carrying personal items that does not exceed 50lbs will be permitted as long as it does not contain hazardous items. Due to space restraints, we are not able to accommodate excess quantities (cases or boxes) of food or beverages. In addition, each passenger can bring one piece of carry-on luggage, which must fit easily in the storage area under the passenger's seat. Carry-on luggage must not exceed **12" x 12" x 24"** in size.

## **BAGGAGE DOLLIES/CARTS**

2-wheel dollies for the purpose of carrying baggage will be permitted to travel on any sailing but are subject to storage in the baggage hold. Any dolly must therefore be able to fit through the baggage hold opening of 24 x 20 inches. **No wagons or 4-wheel dollies will not be allowed to carry baggage on any sailing.** If a 4-wheel dolly can be converted to a 2-wheel dolly, it must be converted before going down the boarding ramp. Once converted to an upright position, (2-wheel dolly) it may not be converted back to a 4-wheel dolly until the passenger is completely off the Catalina Express docks and ramps.

## **STROLLERS**

One stroller is allowed per infant/child at no charge. Strollers should fold securely so they store in the luggage hold. Jogger strollers must collapse and are subject to space availability.

## **BIKES-SURFBOARDS**

Reservations for bikes and surfboards must be made in advance and is subject to space availability. Cost is \$3.00 one-way. Tandem bikes are not allowed at any time. Surfboards can be a maximum of 9 feet long. Windsurfers, Paddleboards or Kayaks are NOT allowed.

## **COOLERS**

Coolers up to 60 quarts and under 50lbs in weight will be accommodated. A cooler counts as a piece of baggage. Ice is available on the island.

## **PETS**

If you carry a pet, a pet waiver must be on file. Pets are to be leashed and muzzled with a commercial muzzle or in a commercial pet carrier while waiting to board the boat and for the duration of the trip. Pets are to stay close to their owners, on the deck. Pets are not allowed in passenger seats or in the aisles where they can obstruct traffic. **Pets are not allowed in commodore lounge with the exception of service animals.** If you are bringing more than 1 pet please check with the ticket counter for approval. Pets are not permitted in the overnight campgrounds on the island.

## **DANGEROUS COMMODITIES**

U.S. Coast Guard prohibits the carrying of dangerous commodities, drugs or weapons on passenger vessels. Fuel, firewood, charcoals, batteries, outboard motors, flammables (i.e.: white gas, liquid fueled camp stoves and lanterns), combustible material or offensive items are prohibited. Propane camp stoves and lanterns are allowed without propane canisters. Propane canisters are available for purchase on Catalina Island. Factory tested items are not allowed on board at anytime, i.e.: generators and motors.

Catalina Express (CCE) shall not be liable for any loss or damage to money, travel currency, jewelry, cameras, glasses and/or other valuables enclosed in baggage. CCE assumes no liability for unlocked baggage, containers without handles, or for any item not adequately packaged or protected from possible injury, or that the inherent nature of the item(s) is fragile, defective or likely to sustain injury even with the exercise of due care in handling by CCE. Any item not enclosed including strollers, carts, golf clubs, fishing gear, etc. will be handled as excess baggage at owner's risk. CCE will transport such items on a space available basis without liability for loss or damage to said property. Passenger assumes full risk and responsibility for insuring the described property against any loss or damage at own expense. Passengers claiming baggage loss or damage must file a written report with either the CCE ticket office or company personnel prior to leaving the dock or terminal area, as CCE will not be responsible for any loss or damage not so reported. CCE will view and photograph all identified. Contract signature indicates acceptance of above guidelines.
