Instructions and Rules:

1. This form is required for Fundamentals Instructor Applicants.
2. **This form requires at least two (2) signatures for submission.** These signatures may be obtained from the Applicant's Fundamentals, Level 1 or 2 Instructor (from the Technical, Cave, Project Diver, PSCR, and/or CCR Programs), and/or any IT or IE.
3. The form provides space for four signatures. Thus, the candidate has options in how they choose to complete the form. Candidates who encounter difficulty securing the signatures necessary to complete the form should contact the Fundamentals Program Director, Irene Homberger, at Irene@gue.com.
4. An individual (regardless of level and/or capacity) may only sign this form once for a particular Applicant. This includes the Program Director for the respective program.
5. Individuals must be active and in good standing for the role in which they sign the form. Any GUE Instructor Evaluator may provide their signature in place of the Applicant's Fundamentals, Level 1, or Level 2 Instructor (subject to the other rules stated herein). However, the Applicant should attempt to secure their Fundamentals, Level 1, and/or Level 2 Instructors' signatures if said Instructors are still active and in good standing.
6. Fundamentals, Level 1, and/or Level 2 Instructors signing this form must have taught the Applicant as a novel trainee (i.e., not as a stand-in trainee or additional trainee filling a course) in a Fundamentals or Level 1 or 2 course in the Technical, Cave, Project Diver, PSCR and/or CCR programs (respectively). The signing Instructor is not required to have taught the Applicant in the program for which they are applying. For example, an Applicant for Fundamentals Instructor may rely on the signatures of their Cave Diver 1 Instructor and Technical Diver 1 Instructor when the latter is an IT (subject to the other rules stated herein).
